Applications are invited in prescribed form for the posts of “Associate Professor (Pay Scale of Rs. 37,400- 67,000/- + Academic Grade Pay Rs. 9,000/-)” and “Professor (Pay Scale of Rs. 37,400- 67,000/- + Academic Grade Pay Rs. 10,000/-)” in the various Departments in this University as detailed in the website.

Qualifications and Experience: As per U. G. C Notification No. F.3-1/2009, dt. 30.06.2010, (please visit U.G.C. website www.ugc.ac.in for details) notified in Gazette of India on 18th September, 2010, U. G. C Notification No. F.1-2/2016 (PS/Amendment) the 4th May, 2016, No.F.1-2/2016(PS/Amendment) dated the 11th July, 2016 and relevant Memorandum of Higher Education Dept., Govt. of W B. No. 120 – Edn.(U)/1U-91/10, Date: 21.02.2011; W B. No. 121 – Edn.(U)/1U-91/10, Date: 21.02.2011; No. 516-Edn(U)/1U-91/10 Dated Kolkata the 16th May, 2017.

Appointments will be made on probation for one year which may be waived or extended in exceptional cases and will be guided by the rules as framed and / or amended from time to time. During or at the end of the period of probation, the service of the Teacher concerned may be terminated with one month’s notice or with one month’s salary in lieu thereof, without assigning any reason thereof. On satisfactory completion of the probationary period the incumbent concerned will be considered for being confirmed in service. Stipulations in respect of Qualification and Experience may be relaxed by the Executive Council in case of exceptionally brilliant candidates on the recommendation of the relevant Selection Committee. The choice of the Selecting Authority need not necessarily be confined only to those who formally apply. **Candidates should apply through proper channel.**

Online filled in forms printed (3 Copies) from the Website along with a copy of the on-line fee receipt of Rs. 2500.00/- (Application fees shall not be charged in case of candidates belonging to the SC/ST. Application fees is Rs. 1250/- for OBC (A), OBC (B) and Physically Challenged candidates) or US \$200 are to be submitted. Applications should reach the office of the undersigned not later than 31/03/2019. However, those who have applied against our earlier advertisement no. Est/1/2009 dated 28.01.2009 and Est/1/2011-12 dated 01.12.2011, need to submit the application form along with all the latest relevant information, documents and the copy of the requisite fee submitted earlier. Such candidates need not deposit fresh application fees along with the application.

All relevant information like API (Academic Performance Indicator), etc. required in accordance with the New UGC Regulations No. F.3-1/2009 dt. 30-06-2010, No. F.1-2/2016 (PS/Amendment) the 4th May, 2016, No.F.1-2/2016 (PS/Amendment) dated the 11th July, 2016 are to be furnished on separate sheets along with supporting documents and to be attached with the application forms. The submission of API by applicants for the post of Associate Professor and Professor be treated as essential. The API calculation shall be based on as per the New UGC regulations No. F.3-1/2009 dated 13.06.2010 and the latest G.O. of Govt. of West Bengal, Dept. of Higher Education, Kolkata. The candidates are required to provide API calculation sheets prepared by them and those are to be

attached with the printed version of on-line applications along with all relevant documents of the API claimed. **A summary sheet** listing all the documents must be submitted along with application.

Service conditions as will be notified by orders of the higher Education Department, Govt. of West Bengal from time to time will be applicable.

Appointment process will strictly abide by the reservation policy of the State Government.

N.B.: Candidates belonging to the **OBC-A & OBC-B** categories, whose caste certificates were issued more than one year ago, must produce a **ratification certificate** from the issuing competent authority that they do not belong to the creamy layer as on the date of advertisement along with copy of previous certificate to enable this University that for the purpose of reservation including SC/ST, the certificate issued by the competent authority within the state of West Bengal shall only be considered valid. Such certificates issued from other states shall not be considered for the purpose of reservation. However, such candidates from the other states may apply as unreserved candidates.

Application received after due date and time will be rejected summarily. Incomplete applications shall also be treated as cancelled and the University Authority shall not be liable to explain any reason in the matter whatsoever. The University will not receive any application after 31.03.2019. The Registrar's Office will remain open from 11.00 A.M. to 5.00 P.M. on 31.3.2019. However, application send by post must have the postage stamp of 31.03.2019. No application form sent by post and having postal mark/date after 31.03.2019 will be accepted.
